## **Full-Steam Ahead for Capitol Square Apartments**



HCA was thrilled to show our state legislators around Capitol Square Apartments at a February breakfast meeting.

On October 17, Governor Patrick's office made an announcement that had us all holding our breath for months our Capitol Square Apartments project was fully funded! With project funding now in place, HCA began to move full-steam ahead with our plans for this 32-unit affordable housing and historic renovation project.

HCA's first step was to finalize our project team. Since designing a thorough and sound renovation plan for the property would be timeconsuming, Davis Square Architects (DSA) was already hard at work. DSA brought many fresh ideas to the table, adding enormous value to the project including major improvements to the two fully-accessible units and making the property more energy efficient without damaging the historic integrity of each building.

HCA next had to focus on hiring a property management firm that could oversee a project of this scale and complexity. Adhering to the layers of public regulations for a property such as Capitol Square is meticulous work, and

therefore HCA needed a partner that was experienced in this area and enthusiastic about working with a missionbased organization such as HCA. After an extensive search, HCA is thrilled to be working with Peabody Properties, Inc. (PPI). PPI has a stellar reputation in the multifamily housing industry. In 2011 alone, PPI was recognized by the Institute for Real Estate Management, MassHousing, the National Affordable Housing Management Association and even won One Family, Inc.'s Champion for Change Award and the MetLife Foundation Award for Excellence in Affordable Housing.

With our architect and property manager in place, HCA needed to engage a general contractor—perhaps the most critical team member, responsible for managing this almost \$3 million renovation project. After interviewing several qualified and experienced firms, in December HCA selected Dellbrook Construction as the general contractor for Capitol Square Apartments. Working with a series of engineers, Dellbrook has designed new heating, plumbing and electrical systems that will improve the living quality for the residents and lower the energy use

of the entire property. The combined expertise of our project team gives us great confidence in our renovation plan and the long term benefits to both the residents of the property as well as the Arlington community overall.
